



FMSTP FEES AND FUNDING STRUCTURE:

Rules Regarding Tuition fees

All fees are payable by the end of each quarter.

All Basotho Physicians practicing in Lesotho are paid for by the ministry of health.

The funding covers all the program costs except for the application and registration fee.

All Non Basotho Physicians working for either CHAL or Government of Lesotho in the Ministry of Health will be charged according to the program fee structure below.

Amendments

All the program fee amendments are determined by the LeBoHA Management, which may amend them at anytime. The amended amount will be payable on request.

Minimum compulsory initial fee	10% of the annual fee excluding registration and application fees

Interruptions in funding sources may require tuition fees adjustments/program operations. In cases of this nature, registrars will be informed ahead of time.

GENERAL COMMENTS

1. Fees and payment requirements differ for Basotho physicians and expatriates working in the country.
2. You will not be allowed to register if the minimum compulsory initial fee has not been received prior or upon registration. (*As highlighted above*)
3. A minimum of 7 working days as a turnaround for the payment to reflect in LeBoHA bank account will be permitted. You will not be able to activate your academic services should the funds fail to reflect in your student account following the turnaround time and a late payment fee will be charged.
4. Fees are payable in quarterly agreement of 25% of the total annual fee, if not paid your student account will be blocked, interest will be charged, and you will not be allowed to sit for exams.
